DEPARTMENT CONVENTION: RE: Department Constitution Article V, Section 2. "At the Department Convention, each chartered Post of The American Legion in the state shall be entitled to five delegates and five alternates; provided the Post has in good standing the fifteen members required for Charter. One additional delegate and alternate is authorized for each additional fifteen members or major fraction thereof. Post membership will be calculated by adding the current paid Post members to those Post 2000 transfers completed during the current renewal year. No delegate shall be seated unless the annual dues have been received by the Department Adjutant prior to Post delegate selection. **Delegates shall be chosen at Post meetings not less than one week** before the Department Convention."

FREDRICK BOWLING JROTC CADET OF THE YEAR:

Send recommendations for the Colonel Frederick B. Bowling JROTC Cadet of the Year to the Department by-May 15, 2025. The cadet selected as the Colonel Frederick B. Bowling JROTC Cadet of the Year will receive a \$3,000.00 educational scholarship. The recommendation must be signed and certified to be accurate by the senior JROTC Instructor.

LEGIONNAIRE OF THE YEAR: Send nominations for Legionnaire of the Year to Department by May 15, 2025.

LEGACY SCHOLARSHIP APPLICATION: Children, adopted child, or stepchild of U.S. military members who died while on active duty on or after September 11, 2001. Children adopted child or stepchild of post-9/11 veterans having been assigned a combined disability rating of 50 percent or greater by the Department of Veterans Affairs also qualify. Each needs-based scholarship provides up to \$20,000 for children of the fallen, and up to \$5,000 for children of disabled people for undergraduate or post-graduate college. Recipients may reapply for additional annual awards up to six times. The application deadline is Wednesday, *March 26, 2025*. After administrative review and approval, scholarship recipients will be notified of their scholarship award between May 9 and May 19, 2025, via the email addressed placed on the application.
